The judge or clerk who delivers the election returns may be paid an additional sum of \$25.00 dollars as provided in accordance with the Election Code Section 32.091 and 32.092.

In the event the candidates for office are unopposed and the secretary of the board of directors or his designee receives certification of same required by Section 2.052(b), Election Code, the secretary or his designee shall post notice that the election is not to be held in compliance with Water Code 49.103.
