5. Discussion and or possible action on not charging customers for wastewater services when they fill their swimming pools for the first time.

Mike stated that he believes the pool adjustment is a good idea for the first fill up. Ted expressed concern that he would like to wait to make any changes like this until after the loan is paid off in 2 years. Discussion was held on the pros and cons of the adjustment. The item was tabled until further notice.

8. Discussion and or possible action on ongoing board approved projects.

- Five-mile water line extension is now complete along FM 1130 from Colony into Cypress Shadows. County provided \$100,000, Cypress Shadows paid approximately \$50,000 and the District put in approximately \$100,000. Cypress Shadows addition still plans to pay for the extension of the wastewater line from FM 1078 into the new addition. The east side of the extension has been cleaned up and the valve box clean up on the west side is ongoing. Over 40 samples were completed between Colony and Cypress Shadows. There are a large number of possible new customers in this area.
- The upcoming project is the repair of the wastewater treatment plant's fence. This is a pending alleged violation from the last TCEQ inspection.
- The Doty Road project is planned to begin in January 2024.
- Installations overall have decreased from 2022 by 20.

- Purchase of new excavator is pending cash flow improvement.
- New billing software has started the transition process and is scheduled to go live in January.
- No budget adjustments for 2023.
- 100's of leaks have been repaired since September due to the drought. Ron King, Water Manager, has done an extraordinary job tracking leaks and flushing to keep the water loss number low.

9. General Managers Report.

Brad presented the general manager's report.

10. Discussion and or possible action on the General Manager's 2023 evaluation.

The board went into closed meeting to discuss General Manager's 2023 evaluation.

11. Closed meeting to deliberate with legal counsel on confidential employee matters.

Entered closed session at 6:46 PM. Opened session at 7:36 PM.

Motion made by Mike West to return a favorable review for General Manager, Brad Haeggquist, to extend his contract for an additional year and his compensation was changed as agreed upon between Brad and the board members, second by Jay Scheiderer.
