
EPA Lead and Copper Inventory Mauriceville Municipal Utility District Customer Survey

Mauriceville Municipal Utility District is in the process of developing the required service line inventory for all of our customer connections. This is required by the EPA to 'get the lead out' of all national water supply systems.

The District has already begun an innovative approach to this inventory process with the aid of a GIS mapping program that has made this much less invasive for our customers. There are still a number of connections that need to be identified as lead, galvanized, copper or plastic. The District would like to ask for voluntary participation in the attached survey that will help us gather the information required.

The diagram at right can assist you in locating your portion of the service line. It shows how homes are connected to public water mains. The service line, owned and maintained by MMUD, is at the road or property line. It connects the public water main to the water meter. The house line connects the water meter to the home. The house line is owned by the customer. We are only interested in gathering the information for the customer owned portion of the service line. Your help with this project will greatly reduce the need for our staff to go to each home individually and dig up the meter box.
