5. Expense accounts and bills for payment.

6. Discussion and or possible action on updating MMUD policies.

Christy and Brad went over the suggested policy and procedure changes in the Personnel Policy and the Water and Sewer Ordinance.

Motion by Ted Williams to approve all policy changes as presented, seconded by Russell Love.

7. Discussion and or possible action on MMUD easement policies and procedures.

Brad presented the board the portions of the Water and Sewer ordinance that mentioned easements. He does not recommend any changes be made to the policy. The current policies do not hinder the district in any way. No action or motions were made.

8. Discussion and or possible action on the FM 1136 well repairs.

FM 1136 well repairs – Original quote was \$60,000, next quote was \$29,000, after repair cost was close to \$2,400. The vendor took the well head off and discovered the issue was a burnt wire. No action or motions were made.

9. Discussion and or possible action on board approved projects.

- Burton estate's 9,000 feet pressure relief project has been completed. No grinders have been lost since the line was activated. Pressure and service calls have been radically reduced.
- Cypress Shadows subdivision was completed in 6 days. 5,000 feet of pipe.
- Later this week the crews will start the rest of the project from Cypress Shadows North on FM 1136 to FM 1078. Fire hydrants will not be installed until the county project is complete.
- 1st 7,500 feet of pipe has been received to begin the water part of the Orange County line extension project on FM 1130. The delivery of pipe has been divided in half in order to keep the district from being out the expense of the pipe that will be refunded by the county for a long period of time.
- Kinard Estates project. Brad will most likely provide an agreement for the Board to review at the November board meeting. The agreement will be between Mauriceville MUD and Blue Topaz Utilities. The agreement will be to sell bulk water to the utility for the Kinard Estates area. The district still has the option to provide sewer to the residents and will require Blue Topaz to turn off water service if they customer does not pay their sewer bill. Mike said he believes this is something the district should pursue further.
- ARPA grant coming up for generators for FM 1130 and Bilbo. The selection committee for grant writer and engineer firm will be Tim McCarver, Ted Williams, Brad Haeggquist, Jeremy Walton and Christy Davis.
- There are no new updates for the Pine Forest well project.
- Once the Orange County FM 1130 project is complete and paid for the district will focus on the Doty Road project.
- Wastewater Treatment plant building will soon be purchased from Home Depot.
- Brad will start updating the master plan.

Motion by Jay Scheiderer to pursue an agreement to sell bulk water to Blue Topaz Utilities for the Kinard Estates area, seconded by Mike West.

All Voted AYE: Motion Carried

10. General Managers Report.

Discussion held on ongoing leaks that would require a boil water notice to repair. Brad would like to wait until there is another reason for a boil water notice and then make the repairs at the same time. Mike and Tim suggested leak tape to use in the interim.

11. Closed meeting to deliberate with legal counsel on confidential employee matters.

Entered closed session at 8:05 PM. Opened session at 8:30 PM.
