- Christy has begun to go to Orange and Newton County Commissioner Courts. At the
 first Orange County Court the Orangefield Water's CDBG grant was closed out. This is
 the grant that the district was denied for 2 years due to the inability of Orangefield
 Water to complete their grant. Christy contacted the grant writers and was informed
 that this year's cycle has passed, but we will start again next year. This grant would be
 for line extensions.
- Orange County Health Department is constructing a new building next to the convention center on 1442. They have received an estimate to connect to our sewer.
 Orange County has also requested an estimate for the county dump on 1442.
